



2019 MVLL ALL STAR PARTICIPATION COMMITMENT FORM

***(RESPONSE REQUIRED whether you are planning to participate in the All Star process or not)***

Mountain View Little League (MVLL) has the opportunity to participate in All Star Tournaments for 8/9/10 year olds, 9/10/11 year olds, Majors (10/11/12), 50-70 (11/12/13), Juniors and Seniors divisions. These tournaments play against other teams within our District, with champions advancing to State tournaments (possibly further for the Majors and 50-70). This is a great experience for all involved and prepares kids for future higher levels of competition. Any player who has played in 60% of their team's games in the Minors, Majors, 50-70, Juniors and Seniors Division and is league age 8-16 is eligible to be selected to an All Star Team. Each team will be comprised of 12-13 players. Before any player may be placed on the ballot for selection to play on an All-Star team, he/she and their parents must agree to the following items (please initial each number – failure to commit to each may jeopardize player eligibility).

**NOTE: 9, 10 AND 11 YEAR OLDS ARE ELIGIBLE FOR MULTIPLE LEVELS OF PLAY; THEY MAY ONLY BE SELECTED FOR ONE TEAM. To be eligible, the player must have played in 60% of their team's regular games.**

1. \_\_\_\_ **YES**, the player will make every effort to attend and all practices and games (practices to begin approximately June 1<sup>st</sup>. 8/9/10 and 9/10/11 games starting June 15<sup>th</sup> through the end of June; Majors 10/11/12 games starting approximately June 22<sup>nd</sup> through July 3<sup>rd</sup>). In addition, if a team wins the District championship, the player will be available from approximately July 9<sup>th</sup> through July 29<sup>th</sup> for the State Tournament.

Note that the residency documents should be dated or in force between 2/1/18 - 2/1/19. Alternatively, a School Enrollment Form will satisfy this requirement.

Exact amount to be determined; MVLL will work with parents and sponsors to minimize this cost as much as possible. In addition, the player and at least one parent will attend the All Star **BBQ** on Saturday, June 8<sup>th</sup> at SRP.
